DEAN'S REGULATION NO 10/2024-2028

4 November 2024

## § 1

Pursuant to §3 pt 5 of the Regulations of the Faculty of Fundamental Problems of Technology, in connection with §17 pt 8 of the Statute of Wroclaw Tech, I appoint the deputies of the Dean of the Faculty of Fundamental Problems of Technology for the term 2024-2028 and entrust them with the coordination of the indicated activities related to the implementation of the Faculty tasks.

**Deputy for the Integration of the Community – dr hab. inż. Gabriela Statkiewicz-Barabach, prof. ucz.**

Initiating and coordinating activities integrating the WPPT community; monitoring and promoting working conditions conducive to improving work culture, psychological safety of employees, counteracting conflicts and work -life balance; developing, improving and monitoring the functioning of Faculty procedures for reporting abuse; promoting information on university procedures for supporting employees and counteracting abuse; identifying the needs of the Faculty of Fundamental Problems of Technology in terms of work comfort and community integration, and initiating and monitoring the implementation of solutions.

**Deputy for the Quality of Education – dr inż. Piotr Sitarek, prof. ucz.**

Preparation of a Faculty schedule of evaluation of classes and coordination of its implementation; determination of the list of classes subject to students' opinion survey; preparation of semester reports on the opinion survey; monitoring and coordination of activities related to ensuring and assessing educational quality; continuous improvement of the Faculty educational quality system; coordinating and supporting preparations for the evaluation by the Polish Accreditation Committee and supervising the implementation of their recommendations; initiating, coordinating and supporting activities aimed at obtaining other accreditations; documenting activities related to educational quality, in particular the quality monitoring and improvement processes; chairing the Faculty Education Quality Council; conducting ongoing reporting on the tasks listed above.

**Deputy for international programmes and international student exchange – dr inż. Katarzyna Wysocka**

Coordinating and supporting the participation of students and staff in international exchange programmes; coordinating cooperation with the Center for International Relations; promoting, monitoring and supporting the participation of the Faculty of Fundamental Problems of Technology students in exchange programmes; monitoring and improving the faculty's service to foreign students, in particular non-Polish-speaking students; conducting ongoing reporting on the tasks listed above; cooperating with the relevant vice-dean with regard to the international promotion of study programmes conducted at the Faculty of Fundamental Problems of Technology; conducting ongoing reporting on the tasks listed above.

**Deputy for student internships – dr hab. inż. Władysław Artur Woźniak, prof. ucz.**

Determining the rules for the implementation of internships within the framework of the applicable laws and internal regulations; approving individual internship programmes; accounting for internships completed; controlling the quality of internships offered; initiating and coordinating activities aimed at improving the quality of internships; conducting ongoing reporting on the tasks listed above.

**Deputy for cooperation – dr hab. Wojciech Linhart, prof. ucz.**

Promoting and coordinating cooperation with the economic environment; coordinating the promotion of the Faculty; cooperation with the Vice-Rector for External Relations in the area of support of cooperation with the environment; supporting contacts with the units of the University in the area of cooperation with the economic environment and obtaining grants; conducting current reporting on the tasks listed above.
